

## DivineBeauty / RejuvaStamp INTERNET POLICIES

DivineBeauty/RejuvaStamp manufactures products in the United States of America and sells motorized equipment only to licensed skincare professionals, licensed cosmetologists, licensed medical practitioners, and other licensed practitioners who can perform skin rejuvenation or beautification treatments and services.

Personalized, individual consultations from skincare professionals are necessary for the proper selection and instruction of DivineBeauty/RejuvaStamp products and procedures in order to insure the best outcome for the patient, aka client. The use of our advanced Electro Collagen Induction Therapy (ECIT) procedures, products, and ECIT equipment, in accordance with the treatment protocols, is of paramount concern for a positive outcome for the client. The client's skin type, condition, and other factors must be considered for the best desired effect. The proper protocol must be considered before a procedure is performed on the client. Accordingly, DivineBeauty/RejuvaStamp's Internet Policies set forth below support our commitment to the supervised use of DivineBeauty/RejuvaStamp instruments and products when performing the ECIT procedure. These policies will be strictly adhered to.

### DivineBeauty/RejuvaStamp Internet Policies

1. DivineBeauty/RejuvaStamp's customers who wish to list DivineBeauty/RejuvaStamp products via the Internet or place DivineBeauty/RejuvaStamp copyrighted material on their Website must first submit:
  - Internet Web address
  - Printout of proposal, or existing Website for review and approval prior to listing DivineBeauty/RejuvaStamp products or copyrighted material on any Internet Website
  - Once approved, customer's company Website may use approved information, art work, or text. The information posted on the Website may not be changed without prior written consent by DivineBeauty/RejuvaStamp.
2. DivineBeauty/RejuvaStamp will authorize the Website listing of DivineBeauty/RejuvaStamp products only as an extension of a legitimate walk-in patient supported medical office, medi-spa, or licensed skincare establishment. The following statement is to be placed prominently on every Web page which shows or communicates information concerning DivineBeauty/RejuvaStamp products or treatment procedures:  
**DivineBeauty/RejuvaStamp's active topical anesthetic products are designed to be used under the supervision of a licensed skincare or health professional.**
3. DivineBeauty/RejuvaStamp will approve the listing of DivineBeauty/RejuvaStamp products only from a Website operated and owned exclusively by an authorized DivineBeauty/RejuvaStamp account, which includes Distributor/Wholesale/Retail accounts.
4. Listing of DivineBeauty/RejuvaStamp products or equipment, or display of DivineBeauty/RejuvaStamp copyrighted materials, including art work, logo, instructional manuals, literature, sales aids, or Before and After photos of Divine Beauty/RejuvaStamp clients, through a second or third party Website, including eBay, Yahoo retail stores, Drugstore.com, or Amazon.com, is prohibited.
5. DivineBeauty/RejuvaStamp has exclusive arrangements with Distributors of DivineBeauty/RejuvaStamp products outside the United States; therefore our Distributors in the United States may sell products to purchasers in the United States only. The following

statement must appear clearly and conspicuously on any Webpage listing DivineBeauty/RejuvaStamp's products or information.

***"We offer DivineBeauty/RejuvaStamp products and equipment tools to users within the United States of America only. Sales outside the United States of America are not allowed by this company."***

6. Only approved Distributor/Wholesale/Retail Websites may list DivineBeauty/RejuvaStamp products.
7. DivineBeauty/RejuvaStamp Accounts are encouraged to resell products at suggested Wholesale or Retail (or within a suggested 20% of retail) prices. DivineBeauty/RejuvaStamp desires Accounts to be successful. It is the policy of DivineBeauty/RejuvaStamp to prohibit its Accounts from advertising or mentioning the price of DivineBeauty/RejuvaStamp's products in general or marketing terms such as "best prices" or "lowest prices," or other specific terms, on Websites. DivineBeauty/RejuvaStamp prefers the statement, "Call for special offer, or promotional pricing."

DivineBeauty/RejuvaStamp reserves all rights to investigate complaints from consumers who have purchased DivineBeauty/RejuvaStamp products via a Distributor/Wholesale/Retail Account's Website and, without notice, retains the right to suspend sales or close the Account that fails to comply with DivineBeauty/RejuvaStamp's Internet policies or conducts business in a way that DivineBeauty/RejuvaStamp deems inappropriate. Should legal litigation be necessary, all costs of attorney fees, filing fees, court costs, or travel for any legal meetings concerning the situation, will be the sole responsibility of the Account that is being investigated, suspended, or closed.
